Application Steps

- 2. Attach copies of all required permits and licenses as necessary for your business. Examples: sales tax certificate, Nursery Grower and Nursery Dealer Registration Certificate, 20-C Food Processing License, Organic certification
- 4. Read and sign the Small Business Incubator Booth application and VENDOR COMPLIANCE AND INDEMNITY AGREEMENT
- 5. Submit application

 - b. By USPS to: Pakatakan Farmers Market, P. O. Box 881, Margaretville, NY 12455

Upon approval, you will also need to submit the following items prior to your first day at the Market:

- 6. A copy of Certificate of Product Liability Insurance with a minimum coverage amount of \$500,000. listing "Pakatakan Farmers Market" as a certificate holder.
- 7. A check payable to "Pakatakan Farmers Market", prepaying for the agreed upon dates.
